- THE SELLER IS REponsible FOR THE DELIVERY OF APPROPRIATE QUALITY GOODS. IF THE QUALITY OF THE DELIVERED GOODS DOES NOT CORRESPOND TO THE SPECIFICATION TO IT, THE SELLER SHALL REIMBURSE THE BUYER FOR ALL DAMAGES RESULTING FROM THE DELIVERY OF THE GOOS IF INADEQUATE QUALITY BY ADJUSTING THE PRICE OF OIL FOR CHANGING THE ACTUAL DENSITY RELATIVE TO THE BASIC VALUE OF 32 APPI AT 60°F BY \$ 0.04 FOR EVERY FULL TENTH OF A DEGREE BELOW 32.00 API.


